THE DUNHAM FOREST TROPHY 2012

ALL MATCHES TO BE PLAYED UNDER R&A RULES AND LOCAL RULES IN FORCE ON THE DAY

1:- Each team will consist of seven players, these being the lowest handicap players available with a handicap limit of not more than 6 (not necessarily the same players in each round), the team must include a PGA professional registered to the relevant club. Please note all amateur players must have a current active handicap.

If your professional is not played, that game will be forfeited. **ATTACHED OR TOURNAMENT PROFESSIONALS MUST NOT BE USED AT ANY TIME.**

You can however include a maximum of two juniors, aged 16 on 1st January 2012 with the required handicap. The remainder of the team must be over the age of 18 on the 1st January 2012, also with the required handicap.

2:- Amateurs must play off their lowest club handicap, the handicap maximum is 6. Players with a higher handicap may be used, however the handicap limit remains 6. Teams must play in handicap order with the **highest pairing FIRST and the professional pairing playing LAST.**

BEFORE PLAY COMMENCES THE TEAM CAPTAINS MUST EXCHANGE TEAM SHEETS IN PLAYING ORDER WITH NAMES, HANDICAP AND AGE. Any club failing to field a full team will forfeit the match not played. **The opponent of the forfeited match must be in attendance and ready to play in order to claim said match.**

3:- All games must be played to a result (**No Halves**) - **Sudden Death.**

Stoke allowance will be the full difference in handicap.

4:- Members of more than one Alliance club can only elect and play for one nominated club, **IN ALL 2012 ALLIANCE TEAM KNOCKOUTS.**

5:- A draw will be made after each round; the first named in the draw will be the home side, and as such are responsible for arranging the match within the specified schedule, failure to do so will lead to disqualification.

You must offer your opponents a choice of **FOUR DATES, AT LEAST TWO OF WHICH, MUST BE WEEKEND DATES.** (i.e. Saturday or Sunday)

PLEASE NOTE BOTH TEAMS SHOULD MAKE EVERY EFFORT TO OPEN LINES OF COMMUNICATION ON RECEIPT OF THE DRAW, this should be arranged as early as possible, **EXTENSIONS WILL NOT BE GRANTED.** If possible a courtesy practice round should be offered to eight players for each round, we suggest posting eight complimentary tickets.

6:- If a match is not completed in the specified period the Alliance Executive will adjudicate, both clubs face the possibility of being scratched from the competition.

THE WINNERS MUST NOTIFY THE ALLIANCE SECRETARY OF THE RESULT IN WRITING BEFORE THE CLOSING DATE OF EACH ROUND.

7:- SHOULD ANY CONTINGENCY ARISE WHICH IS NOT COVERED BY THE RULES, THE DECISION OF THE ALLIANCE EXECUTIVE WILL BE FINAL.
